With reference to the above subject, As per the bus pass circular No 21/2013-OPD(P) Dt 03/06/2013, APSRTC is issuing various types of concessional yearly bus passes.

It is now required to apportion the yearly amount in the P&L Accounts on monthly basis to eliminate the disproportionate reflection of revenue.

The data of yearly bus pass sales amount during the month can be obtained in the website <u>https://mis.apsrtcpass.in</u> under transaction reports, TR65, through regional AOs Logins.

The amount to be apportioned during June should be divided by 10 months and account the same to AH 8535 - Student Bus Passes and the balance amount shall be accounted to AH 0619- Academic yearly student bus pass amount (NEW). Through JE No 1 below this amount shall be withdrawn every month upto March through JE No 2 as below.

The amount to be apportioned during July should be divided by 9 months and account the same to AH 8535- Student Bus Passes and the balance amount shall be accounted to AH 0619- Academic yearly student bus pass amount (NEW). This amount shall be withdrawn every month up to March through JE as below.
