In compliance with the orders of the Govt. of A.P. communicated vide its G.O.Ms.No.224, Tr. R & B, Department, Corporation has implemented revision in the fares of Mofussil Ordinary, Express, Luxury, Deluxe and City Ordinary, Express and Sub-Urban services w.e.f. 11-11-99 vide references 2nd and 3rd cited.

Corporation is presently issuing two types of Monthly Season tickets viz., Ordinary and Express commencing from 10 KMs (2 stages) and upto a maximum distance limit of 100 KMs (20 stages). The tariff of this ticket is fixed on the basis of 20 days up and down normal fare allowing the ticket holder to perform one UP and one DOWN journey on all days of the month including Sundays, Holidays, etc.,

Consequent to increase in the passenger fares the tariff of the Monthly Season Tickets of both Ordinary and Express services would automatically stand revised. The details of Existing and Revised Tariffs are given at Annexure-A, enclosed.

All other terms and conditions governing issue of Monthly Season Tickets remain unchanged. All the Regional Managers/Depot Managers are therefore requested to adhere to the following instructions.


1. The revision in the rate of Season Tickets as at Annexure-A be implemented with immediate effect.

2. The existing stock of Monthly Season Tickets of both Ordinary and Express shall be utilised till they are exhausted by over-stamping to their corresponding higher values duly maintaining necessary accountal.

3. Wide publicity be given through pamphlets and posters for information of the public about the availability of the tickets at 1/3 rd concession on normal fares.
