Sub: **FARES** - Revision of fares in respect of Certain Types of Stage Carriages - Mofussil (Dist. Ordinary, Express, Deluxe and Super Luxury), City Services (City/Suburban Ordinary, Metro Express and Metro Deluxe) and General Bus Pass Tariffs - Reg.

### I. INTRODUCTION :

The Government of A.P. issued Orders vide G.O. 1<sup>st</sup> & 2<sup>nd</sup> cited permitting the Corporation to fix fares in respect of all types of stage carriages with a condition that fare increase shall be done judiciously keeping in view passengers' concerns and carefully analyzing the impact on Occupancy Ratio of the organization.

Corporation revised the fares during the year 2011 in respect of all types of services of all the Mofussil and City buses and issued instructions vide Circular 3<sup>rd</sup> cited.

Government of India has revised the HSD Oil prices w.e.f 14.09.2012 from Rs.44.24 per Ltr. to Rs.50.35 per Ltr. i.e. an increase of Rs.6.11 per Ltr. The additional burden on Corporation due to increase of HSD Oil per annum is Rs.357.75 Crs. and during the year 2012-2013 (14<sup>th</sup> September 2012 to 31<sup>st</sup> March 2013) is Rs.195 Crs.

Despite best operational and maintenance practices Corporation has incurred a loss of Rs.585.31 Crs. during the year 2011-2012 due to frequent agitations, bundh calls. Further the cost of operation since last fare revision increased enormously due to cost escalations in HSD Oil, Stores (material), Workshop, Lubricants, Tyres, and other market related costs etc.

Considering all the above factors and Government Orders vide G.Os. 1<sup>st</sup> & 2<sup>nd</sup> cited, it is decided to revise the fares in respect of Stage Carriage buses i.e., Pallevelugu, Express, Deluxe, Super Luxury, all City/Sub-urban buses operated by the Corporation and different types of Bus Passes being issued to General Commuters, NGOs etc.

The child fare issued through TIMs shall be arrived duly rounding off to the next higher multiple of Rupee. **The Child fare as at Annexure - A** is applicable to the Conductor services operating with Hand Ticket Trays only and not applicable to **CONDUCTOR TIMs Pallevelugu Services**.

The following denomination tickets will be utilized on Special type services being operated with the conductor. The combination of the tickets for these special type services will be according to the existing practice.

**X. INTER-STATE SERVICES :**

The above revised fares are applicable to the services on inter-State routes also for the portion lying in Andhra Pradesh. The Depot Managers operating services on the inter-State routes on reciprocal basis with other STUs, are advised to send the copies of the revised fare table to their counter parts and ensure collection of uniform fares on those services. Further, care should be taken to ensure that there is no variation in the fare structure on the common sector of the routes operated by different Depots.

**XI. COMPUTATION OF FARES FOR EXPRESS / DELUXE / SUPER LUXURY SERVICES :**

The fares for these services are computed based upon the distance i.e., by multiplying the distance with basic fare and then rounding off to the next higher Re.1.00/-. An example for computation of fares for these services is at Annexure-D.

Fare Tables for the above services shall be prepared accordingly.

**XII. GENERAL :**

**CONCESSION TO CAT / VANITHA CARD HOLDERS :**

For Ordinary type services CAT Cards fares are appended at Annexure - A.

For special type services (Express, Deluxe & Super Luxury) to arrive at new concessional CAT Card fares, the following instructions shall be implemented:

“For Special type services the CAT Card fare shall be rounded off to lower side of the rupee if the CAT Card fare arrived is 0.49 Ps. and less and to next one rupee if the CAT Card fare arrived is 0.50 Ps. and above.”

**XIII. CONCLUSION :**

The proposed fares will be effective from the first departure of all types of services on **24.09.2012**. It means the services which depart from any Depot/Terminals on **24.09.2012** ( i.e., from 00.00 Hrs) are to be departed with revised fares as shown above .

All the Unit Officers are hereby directed to take immediate action to prepare MTD 141 Cards and Fare-Tables for each service in accordance with these instructions.

The night-out services which start before 00.00 Hrs. of 23.09.2012 /24.09.2012 and continuing without break shall allow passengers on the old fares only, including the passengers boarding at intermediate stations.

**Advance Reservations :** The crew shall be advised not to collect the difference of fare from the Passengers who reserved their seats prior to revision of fares w.e.f. 24.09.2012.

There is no change in the Student Bus Pass tariff both in Cities and Mofussil areas.
