Vide circular cited at reference (4) above it is decided to introduce Net Banking facility to all ATB Agents to make the system full proof duly dispensing of manual top-up system to arrest the fraudulent activities.

- 1) Vide reference cited at (1) above, AH 2841 and 2842 were prescribed for accountal of Advance Booking earnings. AHs 2841 & 2842 will be continued to be operated for Reservation by RTC Counters (Ground Booking at Bus Stations) **through CASH only.**
- 2) In view of the change in procedure on Top Up amounts by ATB Agents at Corporate level the following New AHs are created.

Therefore, the revised accounting procedure to be followed is detailed below. This has to be implemented w.e.f 1 April, 2013.
