Vide GO MS No.50 dt. 30.12.2019, the regular employees of APSRTC were absorbed by Govt. of AP from 01.01.2020 by creating Public Transport Department (PTD) and the employees does not belong to APSRTC., as far as the salaries aspects are concerned. The Govt. of AP started releasing the net salaries to the employees bank accounts directly through APCFMS by PAO, Govt. of AP. From Jan 2020 to Mar 2020 gross salaries have been booked in the accounts to reflect actual profit or loss of the corporation as the corporation is utilizing the PTD employees for the operations of the corporation.

Now, it is proposed to nullify the gross salaries booked in the accounts from Jan 2020 to Mar 2020 to comply with the GO in ref.1 cited. Earlier the gross salaries paid by the government (net salaries + NDRS) was booked under AH 9235 (Revenue grant from Govt. for salaries). The amount under AH 9235 shall be transferred to the respective the personnel cost Groups under 45, 46, 47, 48, 49, 51, 52, 53, 54, 55, 79, 80, 81, 82 and 5901(Provident Fund) to the **Newly Created XX99** of the relevant groups in every March Accounts to Clear the AH 9235.

Now, the Depots and All Units are required to transfer the balance in AH 9235 to respective personnel cost account heads as given under in March 2020 accounts and in subsequent years March account, so that costing of expenditure is not disturbed in monthly accounts. In monthly accounts the units has to book gross salaries of the corporation to reflect the true Profit or Loss of the Corporation.
