Vide circular cited at 1, the Modified Depot Incentive Scheme was introduced and implemented for all District and City depots of the Corporation with effect from 01.12.2010. Further Vide Circulars cited at 2 to 11 were also issued which are linked with the above main Depot Incentive Scheme circular. **The validity of the scheme is for a period of two years and expires on 30.11.2012.**

In the Existing Depot Incentive Scheme, the procedure for arriving the quarterly average EPK for the fixation of service Target is communicated as per the circular cited at 1, vide para No.3.0.

Now it is modified to adopt total three months calendar days of the previous quarter for arriving quarterly average EPK (Basing on earnings and operated KMs.) for the fixation of service Target instead of 84 to 86 days as is in the existing Scheme.

The VC & MD with the concurrence of FA & CAO has accorded sanction for extension of validity of the existing Depot Incentive Scheme with above modification along with linked depot incentive Schemes at all Depots of the Corporation for a further period of

P.T.O

Two years i.e from 01.12.2012 to 30.11.2014 or till a new revised scheme is implemented whichever is earlier.

All other terms and conditions communicated vide circulars cited, shall remain unchanged.
