Sub: Depot Incentive Scheme – Enhancement of Incentive on passenger ticket from 0.25 Ps. to 0.50 Ps. on sale of each ticket to the Drivers operating Pallevelugu services with TIMs- Circular Instructions Issued- Reg.

Vide Circular cited at 1, the Modified Depot Incentive Scheme was introduced and implemented for all District and City depots of the Corporation with effect from 01.12.2010. Further linked scheme Circulars were also issued which are connected with the above main Depot Incentive Scheme Circular. Vide circular cited at 2, the validity of the existing Depot Incentive Scheme along with linked Schemes is extended for a further period of two years i.e from 01.12.2012 to 30.11.2014.

In the Existing Depot Incentive Scheme, the procedure for paying incentive to the Drivers operating Pallevelugu services with TIMs is communicated as per the circular reference at 1, Vide para no.05.2. (b), the incentive shall be calculated at the rate of 25 paise on sale of ticket to a passenger (adult/child) irrespective of the ticket value. If the driver issues one ticket for more than one passenger, the driver is entitled to receive incentive amount 25 paise for each passenger.

The VC & MD with the concurrence of FA & CAO has accorded sanction for enhancement of Incentive payable to the Drivers operating Pallevelugu services with TIMs (one man service) from **0.25 Ps. to 0.50 Ps. per passenger on ticket sold** where ever such type of services are existing.

Terms and Conditions:

1. The validity of the scheme is co-terminus with the validity of circular No. 07/2012 – IED, dated 21.11.2012
2. The other terms and conditions stipulated vide circular No.23/2010-IED, dt. 26-11-2010 stands good.
3. Whenever the fares are revised, the TIM incentive rates will be reviewed and revised.

4. The Computers Department is advised to make necessary modifications in the software programme for the payment of incentive as per these rates for TIM services.
5. This scheme is also applicable to the Pallevelugu with TIM for Single / two stop Services.
6. These Circular instructions come into force with effect from 01.11.2012.

All other terms and conditions communicated vide circulars cited, shall remain unchanged.
