Sub:- **Depot Incentive Scheme**: Revision of rates of incentive on earnings parameter, service targets and Driver TIM incentive consequent to fare revision with effect from 06-11-2013 – Circular Instructions issued –Reg.

#### I. Introduction:

Vide circular reference cited at 3, Corporation has revised the fares in respect of certain types of Stage Carriages - Moffussil (Dist. Ordinary, Express, Deluxe, Super Luxury etc.,) and City Services (City / Suburban Ordinary, Metro Express and Metro Deluxe etc.,) with effect from 06-11-2013.

In view of revision of the fares, it is necessary to revise the service targets, rates of incentive on earnings parameter and incentive to the drivers operating services with TIMs for different types of services, duly neutralizing the effect of the fare hike.

#### II. Percentage of Fare Increase:

The Impact of the fare revision on various types of services computed in term of

percentages is furnished here under:

#### IV. Revision of Service Targets:

The basic fare of different types of services are revised upward, hence there is a need to revise the service targets to neutralize the bus fare hike.

# 1. Fixation of service targets from 06-11-2013 to 31-12-2013:

In the Existing circular No. 23/2010-IED, Dated: 26-11-2010, vide para 3.1, twelve months are divided into four quarters. Fixation of service targets is being done based on the quarterly average EPK multiplied by the correction factor of the unit communicated and schedule KMs of that service. Since the service target is already fixed taking the average EPK realized during previous quarter i.e., 01.07.2013 to 30.09.2013 by multiplying with the related correction factor of unit and schedule KMs of that service in district and city operation. The targets fixed in pre-revised basic fare shall be revised upward from 06-11-2013 to 31-12-2013 by the type wise % of increase shown in the tables furnished at clause No.II.

For example, a Pallevelugu service target is fixed as Rs.5920.00 in the pre-revised fare, now to fix the target of that service in revised fare, the following procedure shall be followed;

Pallevelugu Service target in Pre-revise fare ( )

: Rs. 5920.00

% of increase in basic fare of Pallevelugu Operation

: 7.27%

Pallevelugu service target in revised fare = (5920.00 X 107.27%) : Rs. 6350.00

Similar calculations shall be carried out for all types of services.

# 2. Fixation of service targets from 01-01-2014 to 31-03-2014:

To fix the target for next quarter i.e from January 2014 to Mach 2014) for a service, the average EPK realized from 01.10.2013 to 31.12.2013 (Previous Quarter) has to be taken. Since the fare hike is implemented from 06.11.2013, the service target for the next quarter (Jan' 2014 to Mar' 2014) shall be done in 3 stages:

- The earnings realized for a service from 01.10.2013 to 05.11.2013 has to be raised Stage (i): upward by the % of increase in basic fare to that corresponding type of operation.
- The earning realized for a service from 06.11.2013 to 31.12.2013 has to be added Stage (ii): to the calculated earnings arrived at stage (i) and has to be considered as the earnings realized for the period 01.10.2013 to 31.12.2013.
- The total KMs operated by that service during the period from 01.10.2013 to Stage (iii): 31.12.2013 shall be taken. The total earnings calculated at stage (ii) shall be divided by the KMs operated, to arrive at average EPK for the period from 01.10.2013 to 31.12.2013. Finally the calculated average EPK has to be multiplied by the quarterly correction factor (Jan' 2014 to Mar' 2014) of respective unit and schedule KMs of that service to fix the service target.

**3.** From April 2014 onwards the service targets shall be worked out as usual as per the procedure mentioned in the existing Circular No. 23/2010-IED, Dated: 26-11-2010 vide clause no.03.0.

# C. Operation of TPT - Tiruchanur (Express):

There is no change of rates of incentive payment for these services as the revised fare is not communicated in the fare revision w.e.f 06-11-2013. Hence the existing rates of incentive shall be continued as per the existing circular No. 23/2010-IED, Dated: 26-11-2010, vide para no. 03.9.4.

## VI. Revision of rates of Incentive to the Drivers operating services with TIMs:

- 1. As per Circular No. 23/2010-IED. Dated 26.11.2010, Vide Clause No. 05.2, incentive amount on sale of tickets issued through TIM was communicated, payable to driver operating services with TIM on the spot with a ceiling limit of Rs. 2000.00 per month per driver. (Including Machine Handling Allowances). The same instructions were reiterated in para no. VI. of circular No. 04/2012-IED, Dated: 26-09-2012.
- 2. Due to fare revision, the incentive to TIM driver for all type of services except City and Pallevelugu, shall be paid at the rate of Re. 1.00 towards incentive per passenger, ticket worth up to Rs. 110.00 and for the tickets worth above Rs.110.00, an amount of Rs.2.00 shall be paid towards incentive per passenger, issued through TIMs.
- 3. Rest of the terms and conditions communicated time to time shall remain unchanged regulating the incentive scheme for the drivers operating services with TIMs.
- These circular instructions will come into force with effect from 06-11-2013, and rest of the terms and conditions issued time to time shall remain unchanged.
- The validity of the scheme is co-terminus with the validity of circular No. 07/2012 IED, Dated: 21.11.2012 i.e. upto 30.11.2014.
- Arrears of incentive amount shall be paid after pre-audit by Regional Accounts Office.
