Sub:- **TIM INCENTIVE** – Payment of TIM incentive/ TIM Handling Allowance to the APPTD Drivers operating Services with TIMs without conductor – Orders issued – Reg.

- 1.0** TIM incentive scheme to the Drivers operating services with TIMs without conductor was introduced in the year 2000, to improve the revenues and to reduce the cost of operation. Modifications are being carried out from time to time in this scheme, to motivate the drivers to perform TIM duties with interest.
- 2.0.** Based on the G.O.Ms.No.114, Dt.03.06.2022, Vide ref.1<sup>st</sup> & 2<sup>nd</sup> cited, instructions were issued on TIM Incentive to the APPTD Drivers who are operating TIMs without conductor for Express, Ultra Deluxe, Super Luxury & Indra Services only.
- 3.0.** Vide ref.3<sup>rd</sup> cited, VC & MD extended TIM Incentive to APPTD Drivers operating without Conductor (Excluding PHB & Out-Sourcing Drivers) for Other AC Services, UPVG, PVG, City Ord. & Metro Exp.
- 4.0.** **Competent Authority has approved to pay TIM Handling allowance @ Rs.50.00** per duty per Driver to all AC Products **except Indra**. The amount payable to the driver will be TIM Handling allowance or TIM incentive amount earned due to issue of tickets through TIM whichever is higher. This amount shall be paid on **SPOT** after spell of duty, as per Clause No.03.c of circular ref. 1<sup>st</sup> cited.

**4.1.** Threshold fares for **TIM incentive** are furnished below:

**4.2.** The above threshold fares are exclusive of Passenger cess, Tollgate plaza earnings, Luggage earnings, TAYL, Sale proceeds of RFID cards, Recharge amounts on RFID cards, Safety cess, GST & Fuel cess etc., i.e. on basic fare charged only.

**4.3.** The TIM Driver is allowed Rs.1/- as an Incentive amount for the ticket fare collected less than or equivalent to the Threshold fare of that particular product and thereafter allowed Rs.2/- per each passenger ticket issued.

**5.0. TIM incentive 50 Ps.** to Pallevelugu, City Ordinary & Metro Express Services operating with APPTD Drivers without Conductor:

- ii. These Instructions are shall come into force w.e.f. **01.04.2024**.
- iii. All other terms and conditions communicated from time to time for payment of the TIM Handling allowance / TIM incentive in depots vide Circular No. 03/2022-IED & 04/2022-IED issued by IED-APSRTC, are stands good on this subject.
- iv. Whenever fares are revised, the threshold fare for TIM incentive will be reviewed and revised.
- v. IT Department has made necessary modifications in the relevant software as approved by the competent authority.
