To motivate the employees of the corporation working in the depots, Depot Incentive Schemes are being operated since 1980. Further modified Depot Incentive Scheme was introduced and implemented w.e.f.01.12.2010 vide circular 1st cited and the scheme was being extended from time to time with certain modifications and valid upto 30.11.2018 vide circular 5th cited.

In view of rationalization of City Ordinary and Metro Express services, there is increase and decrease in the Tariff's (City Fares). The revised fares of City services (City Ordinary & Metro Express) are implemented from 01.08.2017.

The minimum fare presently being charged at Rs.7.00/- in City Ordinary & and Rs.8.00/- in Metro Express services to Rs.5.00/- uniformly and also the fares are marginalized to the passenger convenience in tendering the exact change amount.

The approved payable incentive rates applicable to the crew in these City Ordinary & Metro Express services are shown below:
