Sub: - MAN HOUR RATE- Revision of Man Hour Rate of all Tyre retreading shops applicable from 01-04-2007 to 31-03-2009 OR as per the conclusions drawn on finalization of Management agenda, whichever occurs earlier - Communication-Regarding.

The approval of VC & MD with the concurrence of CAO on calculation of Man Hour Rate to all production units for the period 01-04-07 to 31-03-09 based on the procedure in vogue and taking into consideration outsourced activities and manpower and their wages was communicated vide reference letters 2nd cited.

Accordingly, the revised Man Hour Rates for all the Tyre retreading shops were communicated vide circulars reference 3rd cited after receiving the audited information from the units on Pay, DA particulars of RTC employees and particulars of outsourced persons & their wages .

Based on the representations received, VC & MD with the concurrence of CAO has approved vide case under reference 4th cited, for computation of man hour rate system at all production units duly following the pre-revised method for the period 01-04-2007 to 31-03-2009 or as per the finalization of management agenda and to consider the outsource persons with input man hours of 175 per worker per month at ZWSs, BBBU & PP and 163 input man hours for TRSs so as to exclude the work content of outsourced from the total production in arriving %PL.

Vide reference 5th cited, the same was communicated to all the production units and informed that the revised Man Hour Rate shall be calculated and will be intimated in due course by IED.

The revised Man Hour Rates of all Tyre retreading shops based on the Pay, DA particulars of RTC employees are fixed as follows:
