Sub: **DIS-CONDUCTORS' JOB SECURITY**-Modification of Certain eligibility clauses for allowing month end incentive payment on earning parameter to conductors involved in Cash & Tickets irregularity cases- Communication-Reg.

Vide reference cited at 1 & 2, certain relaxation in eligibility clauses while allowing month end incentive amount payable to the conductors, involved in cash & tickets irregularity cases is made.

Consequent to the above clause no. 13.1 of circular cited at reference 3 is modified partly and may read as follows, applicable to moffusil (District) depots, with effect from 15-02-2008.

For Moffusil (District) Depots:

Existing as per circular no. 08/2004-IED	Modified
13.1.a)2 "The month end incentive amount accrued on earning parameter till date of involvement will be forfeited. However the conductor is eligible for drawl of incentive on earning parameter from the day he perform duty after his involvement, provided he is not placed under suspension subject to fulfillment of other eligibility conditions."	13.1.a)2 "Conductors involved in Cash & tickets irregularities cases for more than one time in a month are not eligible for month end incentive."

For the Depots of Hyderabad & Secundrabad City Regions:

Existing as per circular no. 08/2004-IED	Modified
13.1.b)2 "Conductors involved in Cash & tickets irregularities cases for more than two times in a month, are not eligible for month end incentive."	-NO CHANGE-

All other terms & conditions stipulated in the existing circulars regulating incentive payment for depots remain unchanged.
