VC & MD with the concurrence of CAO has approved vide case under reference 1, to revise the Man Hour Rate of all production units from 01-04-2007 to 31-03-2009 based on the procedure in vogue and taking into consideration outsourced activities and manpower and their wages as vacancies are dealt by outsourced persons.

The validity of this procedure is for the period 01-04-2007 to 31-03-2009 or as per the conclusions drawn on finalization of Management agenda, whichever occurs earlier and the Man Hour Rate will be reviewed at the time of Reconciliation after obtaining the data for every six months in a prescribed proforma. Vide letters under reference 3 & 5, this was informed to the Units.

Vide letter under reference 1, the WM: ZWS: VZM has submitted the PAY+DA particulars of workmen of ZWS: VZM for the months of JANUARY'07, FEBRUARY'07 & MARCH'07 duly audited for the approval of Man Hour Rate. Vide letter under reference 4, the WM: VZM has informed that no person is being engaged on casual/contract/outsourced basis and no activity is being on outsourced basis

The PAY+DA particulars were verified at this office and the Man Hour Rate fixed for Vizianagaram Workshop is **Rs.47.04** (Rupees forty seven and four paise only) This will be applicable from 1.4.2007 to 31.3.2009 or as per the conclusions drawn on finalization of Management agenda, whichever occurs earlier and will be reviewed at the time of Reconciliation.
