Sub: -DIS – Payment of Incentive to crew for operating Special Services – Certain Modifications to the Circular instructions - issued – Reg.

Circular instructions were issued vide reference 3rd cited, whenever special type of operations carried-out, the incentive on special operations shall be allowed to the crew members, if the special trip(s) is operated with 1.3 times of its normal fare for Express / Deluxe services and 1.50 times of its normal fare for Super Luxury and above types of services as the case may be, in one of the trip.

Vide reference 5th cited, instructions were issued, not to collect more than the normal fare for all special type services operated in addition to the schedule services to various destinations to clear additional traffic during Dasara festival holidays for the year 2007 and during the period of Special drive initiated by Transport Department, till further instructions.

Vide reference 6th cited instructions were issued to continue the collection of additional fare to the special type of services operated for inter state destinations, by collecting 1.5 times of the normal fare for Super Luxury and above type services and 1.3 times of the normal fare for remaining special type services (Express and Deluxe services).

Vide reference 7th cited, instructions are issued to operate additional services to clear the additional traffic during holidays and festivals and charge

1.30 times of normal fare for Express and Deluxe services and 1.50 times of normal fare for Super Luxury and above types of services.


In view of the above instructions, the conditions stipulated at para No.4 of Circular No. 15/2006-IED are modified and as follows: "The Scheme is applicable to special type of operations, specified at clause Nos. (i) to (iv) of item no.2, for all types of buses (except Garuda / Garuda plus) , operated only with 1.30 times/more than 1.30 times of its normal Express/Deluxe/Super Luxury fares, as the case may be in any trip(s). In respect of special services operated with any fare, less than Express fare, even with 1.30 times of such fares, no incentive can be paid under this scheme".

Hence the clause no. 9 of the item no. IV of the Circular no. 05/2007-IED, dated: 14-09-2007, shall read with the above modification.

The rest of the clauses, terms and conditions stipulated in the Circular No. 15/2006-IED, Dated, 18.10.2006 shall remain unchanged

The validity of the Circular No. 15/2006-IED, Dated 18.10.2006 is extended up to 31.03.2009 or a new scheme is designed and implemented or any modifications carried-out on this subject, which ever is earlier. .
