Vide reference 1st cited, PIB scheme is in operation at Bus Body Building Unit: Miyapur existing PIB scheme was introduced with effect from Oct'2006 and vide reference 3rd cited, the scheme validity was extended upto Sept'2015.

Vide reference 2nd cited, PIB scheme is in operation at Printing Press: Miyapur. existing PIB scheme was introduced with effect from Dec'2006 and vide reference 4th cited, the scheme is valid up to Nov'2015.

Vide circular no.13/2004-IED, the provision of man power in all 7 Tyre Retreading Shops is made on average production demand equating to 125%PL.

At all 7 Zonal workshops, Vide Circular No.02/2014, dt.16.9.2014 the provision of man power based on the production given, the man power is provided at 125%PL.

At present the effective man hours at BBBU&PP:MYP are 157, it is only 79.03%PL. There is a scope to increase the effective man hours upto 198.67 hours for effective utilization of men.

As per the Circular No. 14/2006-IED, dt.26.9.2006, of BBBU:MYP vide para no.17 "ED (E) is authorized to incorporate any other changes/ modifications in this scheme as may be considered necessary form time to time, in consultation with the CE(IE)&CA".

The competent authority has approved to provide the man power at 125%PL to make uniform at all Production Units of the Corporation.
