Vide circulars under reference 1 & 2, the Man Hour Rates of all production units will be revised once in TWO years in the month of APRIL considering the average salaries paid (PAY+DA only) to the workmen during preceding three months i.e. JANUARY, FEBRUARY & MARCH.

Vide letter cited at reference 3, the PO: VZM has submitted the PAY+DA particulars of work men of ZWS: VZM for the months of JANUARY2001, FEBRUARY2001 & MARCH2001 duly audited by DY.CAO:VZM for the approval of Man Hour Rate which is applicable for the period w.e.f 1-4-2001 to 31-3-2003.

The PAY+DA particulars were verified at this office and the Man Hour Rate arrived at **Rs. 27.51 ps.** (Rupees twenty seven and paise fifty one only), which is applicable from 1-4-2001 to 31-3-2003.

All the conditions communicated in the circulars cited under ref. 1 & 2 are remain unaltered.
