The Modified Depot Incentive Scheme was introduced and implemented for all Depots of the Corporation w.e.f 01.12.2010, vide circular cited at 1, with a validity of two years i.e., upto 30.11.2012. Subsequently, vide Circular cited at 3, the validity of the main scheme along with other linked schemes was extended for a further period of two years w.e.f 01.12.2014 i.e., upto 30.11.2016.

Further vide circulars cited at 4 to 7, the additional linked scheme circulars were issued. **The validity of the schemes are also ending on 30.11.2016.**

VC & MD with the concurrence of FA & CAO has accorded sanction for the extension of validity of the existing modified Depot Incentive Scheme along with all linked Schemes at all Depots of the Corporation for a further period of two years i.e. **from 01.12.2016 to 30.11.2018**
