Sub: **REWARDS** - Reward Scheme to the Drivers of Private Hire Buses on earnings parameter

With a main objective to motivate the Private Hire Bus (PHB) drivers, in enforcing the steps taken by the Corporation in improving Occupancy Ratio, Punctuality, Regularity etc., the Reward Scheme was introduced and implemented for one year to the Drivers of PHB in APSRTC on earnings parameter in all depots of the Corporation w.e.f. 01.11.2012 vide Circular cited at 2 and the scheme was subsequently extended from time to time and as per Circular at 5th cited the validity of the scheme is going to expired 31.10.2016.

VC & MD with the concurrence of FA has accorded sanction to extend the validity of the existing reward scheme for one more year from November 2016 to October 2017 to the Drivers of Private Hire Buses on earnings parameter only, at all Depots of the Corporation.

Vide reference 2nd cited the monthly post audited sheets by the accounts wing of the office of the Regional Manager concerned, shall send a copy of the same to Industrial Engineering Department for analysis and record.

Further principals of ZSTCs are advised to initiate special drive to conduct training class to all the drivers of PHBs on this Reward Scheme.

All other terms and conditions communicated vide circulars cited, shall remain unchanged.
