Sub: **TIM REWARDS** – TIM Reward Scheme to the Drivers of Special type Private Hire Buses operating with TIMs – Circular Instructions issued - Reg.

Vide reference 1st cited, TIM incentive scheme was introduced in the Corporation to the RTC drivers operating with TIMs.

TIM incentive amount is being paid on spot, in addition to the spot payment of incentive amount on service earnings to RTC drivers. The scheme is being modified from time to time to suit the business environment.

Vide reference 4th cited, the payable incentive rates applicable to the RTC drivers for operating the services with TIMs are revised due to fare revision and communicated.

Vide reference 6th cited, ED(O,M&C,PROJ) communicated that similar TIM incentive shall be paid to the drivers of Hire Buses operating Special type buses with TIMs and informed IED to issue the guidelines to incentive payment to the drivers of special type Private Hire Buses, operating TIMs.

The following guidelines are issued to pay incentive to the drivers operating special type Private Hire Buses with TIMs and without RTC Conductors.

1. The PHB driver is allowed Re.1/- , upto the threshold adult ticket fare and thereafter Rs.2/-, for each passenger ticket, on the tickets issued through TIMs for special type of services as TIM reward. The threshold fares are indicated in the following paras
2. This is in addition to the reward amount being paid on earnings parameter on par RTC driver.

The above threshold fares are not inclusive of passenger cess, Tollgate plaza fee etc.

3. There is no ceiling limit for this TIM reward amount.
4. TIM handling allowance of Rs.15/- per duty per driver shall be allowed. This handling allowance amount will be compared to the incentive amount earned due to issue of tickets through TIM and paid whichever is higher.
5. The safety & security of TIM and coach earnings lies with PHB owner and responsible for mishandling/misuse/missing/damage of TIM, misappropriation of cash / C&T irregularities etc., and in remittance of complete service earnings immediately after completion of the duty.
6. These circular instructions are valid upto 31.10.2016 'OR' when schemes are revised and whichever occurs on earlier date.
7. This scheme shall be withdrawn without any prior notice or at any point of time.
8. Whenever the fares are revised, the above clauses will be reviewed and revised.
9. The terms and conditions mentioned in Circular No.05/2012 are holds good.
10. IT department is requested to make necessary modifications in the software concerned.
