Sub:- TIM INCENTIVE – Payment of TIM incentive/ Reward, TIM handling allowance and TDA to the Drivers operating TIMs – Revision of incentive threshold slab rates on implementation of fare hike vide Circular No.09/2022-OPD(P), Dt.13.04.2022 – Communication of approval – Reg.

- 1.0 Our corporation is utilizing TICKET ISSUING MACHINEs (TIMs) to improve the productivity of the crew thereby minimizing the cost of operation. Further by allowing incentive amount to the drivers who are operating TIM service without conductor pave the way to reduce the cost of the operation. An incentive scheme was designed and kept in operation for TIM drivers, since the year 2000. Modifications are being carried out from time to time in this scheme to motivate the drivers to perform and opt more and more TIM duties and validity of the scheme was subsequently extended from time to time. At present the scheme was extended up to 31.10.2022 vide ref. 12<sup>th</sup> cited.
- Vide ref.14<sup>th</sup> cited, APSRTC has revised the fares of certain types of Stage Carriages

   Mofussil (Pallevelugu, Ultra Pallevelugu, Super Luxury AC, Indra, Garuda, Amaravati, Dolphin Cruise, Night Rider 42, Night Rider 48, Vennela-24, Vennela-30 & Metro Luxury A/C) and City Services (City Ordinary, Metro Express etc.) w.e.f., 14.04.2022.

The TIM driver is allowed Re.1/- as incentive amount for the ticket fare collected which is equitant up to the threshold fare for that particular product per passenger per ticket and thereafter Re.2/- for each passenger on ticket issued through TIMs.

- **3.2** The above threshold fares are exclusive of Passenger cess, Tollgate plaza earnings, Luggage earnings, TAYL, Sale proceeds of RFID cards, Recharge amounts on RFID cards, Safety cess, GST & Fuel cess etc., and based on basic fare charged only.
- 4.0 IT Department is informed to make necessary modifications in the relevant software as approved by the competent authority.
- 5.0 The non-paid TIM incentive amounts to the TIM drivers (RTC & PHB) shall be paid after pre audit by the office concerned w.e.f., 14.04.2022.
- 6.0 Whenever fares are revised, the above clauses will be reviewed and revised.

## 7.0 TIM Reward amount on issue of tickets from TIMs i.e. conductor less services of PHB driver shall be paid on the spot, on par with the RTC driver.

All other terms and conditions communicated from time to time for payment of the TIM Handling allowance / TIM incentive and TIM driver allowance (TDA) in depots vide Circular Nos. 2/2000, 23/2010, 5/2012, 10/2014, 05/2015, 03/2016, 04/2016, 06/2016, 01/2017, 10/2018, 03/2019, 01/2020, 05/2020 and 03/2021-IED issued by IED, APSRTC shall remain unchanged.

These instructions are valid up to 31.05.2022 and further instructions will be given due course for implementing from 01.06.2022.
