RMIS project has been implemented at all Regions of the Corporation. The data for the project consisting of all daily transactions of OLTAS/DOLTAS, VEMAS i.e Daily Earnings Statement(108), Daily Operations Statement(1 10), Log Sheet Challan (42A), Off road position, cancellations and break downs of buses etc., will be pooled by the RMIS Offices from depots either through Modems or floppies.

The implementation of ZMIS/RMIS projects at various Regions of the Corporation is closely monitored through regular reviews at head office to achieve the following benefits.

- 1.To eliminate the duplication of work at MIS sections of the Corporation i.e. second time data entry of figures by operator which takes considerable time.
- 2.To Store the data of individual service / route / vehicle / depot / Region performance for about 5 years.
- 3.To generate the queries of important parameters like EPK / KMPL / EPB / VU / OR of each service / route / depot etc., with simple commands.
- 4. To take corrective action immediately since reports are generated timely.
- 5.To eliminate wrong punching of data of important parameters to get accurate figures for taking action.

For effective implementation of ZMIS / RMIS Zones and Regions the data at depots should be generated correctly. It is observed from the scrutiny of RMIS generated reports that many of the depots are not feeding the cancellation / breakdown / offroad data correctly. The report sent from depots is not at all tallying with RMIS project generated reports.

The reason for the above variation is due to the fact that in some depots the figures in the computer generated reports are being manipulated through 'VI' text editor and sending these changed statements to Regional Manager's Office. Due to this practice, the figures in the statement are not tallying with actual data which is pooled through Modems.

All the Depot Managers are therefore directed to take necessary steps to stop usage of Vi' text editor or any other editor to manipulate the figures in the reports.

Any violation of the directive will be brought to VC & MD's notice, apart from inviting severe disciplinary action on the System Supervisor / Depot manager.

The receipt of this circular shall be acknowledged by the Depot Manager.
