Sub: **INCENTIVES** - Incentive to the Drivers using Ticket Issuing Machines - Reg.

Ticket Issuing Machines are introduced for the first time at Hyderabad-I nd Vijayawada Depots on trial basis in the month of June 2000. The incentive cheme to the Drivers using Ticket Issuing Machines has been introduced vide ircular lsl cited. The validity of the circular was extended for three months upto ovember, 2000, vide circular 2<sup>nd</sup> cited.

VC 8s MD with the concurrence of FA has now accorded approval for the xtension of the validity of incentive scheme to Drivers using Ticket Issuing [achines, for a further period of one year i.e. upto 30.11.2001, with modification ) Para No.5 of the above circular as shown below:

## 5. MAXIMUM INCENTIVE PAYABLE:

The maximum ceiling limit for such payment on the sale of tickets through Ticket Issuing Machines including machine handling charges was fixed at Rs.500/- per month.

The ceiling limit is now enhanced to Rs.750/- (Rupees Seven Hundred and Fifty only) subject to the following conditions:

- i) The Driver should perform at least 15 duties in a month on the following type of services:
- -The service which was earlier operated as conductor service at least for the last six (6) months, or since its introduction, and now converted as one man service with TIMs.
- -However, if the driver operates the TIMs only on such services which were operated as "One man" service prior to introduction of TIMs., the payment in respect of such drivers shall be limited to Rs.500/- a month.
- ii) The certification of Dy.CTM of the Region shall be obtained for these types of services which are converted from conductor services to one man services.

These payments will be in addition to the Crew Allowances and the Depot Incentive amount currently being paid to the Drivers.
