It is decide to delegate the powers vested with VC & MD vide item no 36(a),section-4 "FINANCIAL MATTERS" of Delegation of Powers, 1994, as given under.

	2.	If replacer to the effe from the r	ment is required before six years period a certification bet that the printer is unserviceable shall be obtained manufacturer/distributor/athourized service provider, only replacement shall be sanctioned.	

* Currently printers are being procured with three years comprehensive onsite warranty.

The following guidelines shall be followed will taking up replacement of printers.

- 1. The unit history cards with date of installation, details of problem and repairs got done have to be pursued by the sanctioned authority before replacement is sanctioned.
- 2. Replacement shall be taken up only on buy back basis so as to realize some amount as salvage value for the old printers.
- 3. Replacement of printers shall be done through the concerned zonal stores for sanctions accorded in zones/regions.
- 4. Tender shall be invited by the zonal stores only from the notified approved sources and for approved specifications communicated by the computer department from time to time.
- 5. The current approved makes and models for nine pin, 136 column printers which are most widely used in the corporation are given below.
 - a) TVSE MSP 255 XL classic (MAKE : TVSE)
 - b) WIPRO EX 330+DX (MAKE : WIPRO)
 - c) EPSON EX 1170 (MAKE : EPSON)

The makes and models for other type of printers may be clarified from the computer department as and when required.

The quotations shall be invited directly from the manufacturers onluy.

The powers delegated now are only for replacement of existing printers which have outlived their life span and for procurement of new printers. For procurement of new printers the existing delegation s of powers hold good.
