The importance of availability of basic data of the depots at various levels is increasing day by day for detailed analysis and for better and faster decision making. Collection of basic data every time from the depots and consolidation of information is a very important and laborious task. It has been proposed to collect the basic data directly from the depot system.

As such a Web based new project was developed and implemented in the Corporate MIS section namely CPRS (Centralised Performance Reporting System). This project was developed with an objective to build a Centralised Data Bank at Corporate Office to have root level performance particulars and also information availability to all levels of Line Mangers as well as Functional Management for review and analysis through Internet. Unless the data is received from Depot fully and regularly from depots, the project will be defunct.

Depot is the main information generating center. The depot data is collected directly from the Depot Systems through APSWAN and all the depots data is processed in the Server located at CMIS, Head Office. This processed data is available for viewing through the Internet at any level viz,. Depot wise. Region wise, Zone wise and Corporate level etc.

All the reports that are generated through this project can be viewed by all the Managers through Internet. The following are the advantages of project.

- 1.Building up of Centralised Data Bank at Corporate Office to develop various analytical reports for strategic planning
- 2.Information availability to all levels of Field as well as Functional Mangement for review and analysis.
- 3. Fast and information based decision can be taken by the Line Mangers and superior officers to contain redundant operations.
- 4. No manual intervention in preparation of reports.
- 5. Uniform information at all levels.
- 6. Various reports on Depot/Region/Zone and Corporate Performance can be developed through this project.
- 7. No delay in compilation and generation of reports
- 8. Guidance can be given to the Depot Managers for improving the performance by the Senior Officers.
- 9.To save money and time through avoid the collecting Hard copies from the Units Hence, the Depot Mangers are requested to transmit the MIS files daily thro APS WAN without fail so that CMIS can process the data and consolidate the information.
