Sub: - TYRES - Reconciliation of Tyres at Depots and Zonal Stores - Instructions issued - Reg.

With reference to the letters cited above, instructions were issued to take immediate action by Depot Managers to delete the unconnected tyres in the depots duly following the procedure:

Even after laps of six months some depots have not submitted the soft copy of the total tyres available in the depot to COS/Zone to identify the Unconnected tyres at Zonal Stores and hence affecting the depot wise, Zone wise and corporation wise reconciliation.

Hence the following instructions are once again reiterated for getting correct reconciliation of tyres of every depot at corporate level.

Procedure to be followed at depot:-

- 1. Down load program "tyremasop.cob" from "TRCWAN"/DCP/TPTOBJ/vemas directory to depot/tptobj/vemas directory;
- 2. Take the physical census of tyres on 31-12-2013 as per the standard procedure. Run to tyres bunch wise statement program (tycensus.rpt). If any unconnected tyres are available. Mark these tyres as unconnected duly running the "TYRE MASTER OPERATION" program through "VEMAS" main menu. The Tyres marked as unconnected will not reflect in tyre census statement, tyre reconciliation statement and in tyres bunch wise statement.
- 3. After ascertaining the correct VEHICLE TYE (i.e., DISTRICT/CITY/LONG DISTANCCE) in vehicle master for all vehicles, runs the TYRES CCENSUS AND RECONCILIATION statement from "VEMAS" main menu. The generated "depotcodeMMYYtcentot.dat and depotcode MMYYtcen.dat" file should be kept in "RTCWAN"/hodata/directory.
- 4. If any tyres are marked as unconnected, the Depot Managers shall process a note file to DY.CME(SM-IT)/HO duly taking the sanction of competent authority as per procedure for deletion of these tyres from "VEMAS" master.

5. With the help of Regional Core Group Supervisor confirm the implementation of the program at Depot level.

Procedure to be followed at Zonal Stores:-

- 1. Down load the programs viz., tyrecensus.sql and tyre_census.inp available in "/home/olimsho/modifsw" directory of RTCWAN. Run the tyrecensus.sql report which in turn generates the list of tyres available at J-ward and TRS of respective Zonal stores.
- 2. Perform the physical verification of tyres (Tyres Census) at end of the year (30th June 2014) as per the procedure in vogue.
- 3. Mark (round off) the tyres with RTC NOs which are present in the Tyres Census data list and physically not available either at J-ward or TRS.
- 4. Enter the details tyres, which are not physically available through the form. (Tyres_census).
- 5. After completion of the entry of not available tyres, commit the transaction, which will change the flag of current classification code(cur cls cd) the tyres to "US" (unserviceable).
- 6. Run the Tyres Census reports (tyos.sql, tychk.sql) every month end and upload the zone wise tyre census data report (viz.VJAtyrecens.at) in "/home/hodata" of RTCWAN without fail.
- 7. With the help of OLIMS System-in-charge confirm and implement the software

Hence, all the Regional Managers are requested to instruct the Dy.CMEs and Depot Mangers to complete the above procedure by 30.06.2014 and submit compliance to the undersigned. Executive Directors (Zones) are requested to advise the Controller of Stores and SO(D & T) to complete the task by 30.06.2014.
