Vide ref. 2nd cited, guidelines regarding bulk material transport are issued. It is also mentioned that customers sending less quantities to each destination on a day, but more than 10 tons in a month to be treated as bulk customers. But no tariff was communicated for these customers.

Working instructions for bulk customers sending more than 10 tons in a calendar month, but less than one ton quantity for each destination on a day are as follows:

- 1. Separate LR book to be maintained for each bulk customers till computerization is completed.
- 2. Calculation of amount to be collected has to be arrived at as shown in the given below example.
- 3. There is no restriction for bulk customers on number of destinations to transport their material from one origin.

VC&MD with the concurrence of FA has accorded approval for the following:-

1) To extend bulk rates to all customers sending less than 1 ton to one

To extend bulk rates to an one than 10 tons in a calendar month or as destination, subject to sending more than 10 tons in a calendar month and when the 10 tons quantity is completed in a calendar month. and when the 10 tolls quality.

2) For part loads booked by bulk customers, flat rate of Rs. 2.50 per km/ton

(dickey load) as detailed in the example on pro-rata basis to be charged subject to availability of space upto 15.07.2017.

3) Rates and terms will be as applicable to bulk customers.

Therefore all Regional Managers, Dy.CTMs (M&C), ATMs(Comm.), Dy CTMs and DMs are advised to take initiative to see that maximum bulk customers utilize APSRTC Logistics to increase Commercial Revenue.
