Detailed Schedule of Rates, terms & Conditions applicable for different Categories APTRANSCO consumers was communicated vide Circular cited at Reference (1) which w valid from 4-6-2000 to 31-3-2001.

APTRANSCO vide their letter cited at reference (2) informed latest Schedule of Rates, terms & Conditions applicable for different Categories of consumers valid with effect from 1-4-2001 to 31-3-2002.

In the revised Schedule of APTRANSCO except the Tariff for LT Category-I Domestic the Tariff for other Categories communicated vide Circular No. 25 / 2000-MED, date 30-6-2000 remains unchanged. The revised Tariff for LT Category-I Domestic are furnish hereunder.

L. T. CATEGORY-I : DOMESTIC

: Applicability :

Applicable for supply of energy for lights and fans and other domestic purposes domestic premises.

Rates :

Consumers shall pay electricity charges as shown below :

0 -	50 Units/Month	135 Paise per unit
51 -	100 Units/Month	260 Paise per unit
101 -	200 Units/Month	285 Paise per unit
201 -	300 Units/Month	450 Paise per unit
301 -	400 Units/Month	500 Paise per unit
above 400 Units/Month		575 Paise per unit

Subject to monthly minimum charges of:

Single Phase :

Upto 250 W	...	Rs. 25/- per month
Above 250 W	...	Rs. 50/- per month
Three Phase	...	Rs. 150/- per month

Except the change in the L. T. Category-I Domestic as shown above the other Schedule of Rates, Terms & Conditions communicated vide Circular No. 25/2000-MED, dated 30 2000 remains unchanged. As the slabs are increased from 4 to 6 with judicious usage of electricity. We can reduce the payments considerably.

The Depot Managers/Paying Officers are therefore advised to go through the Gazette Notifications of APTRANSCO for any changes in Tariffs for making subsequent payment.

These instructions are given only just as guidelines to the Paying Officers against the Bills raised by the APTRANSCO.

No excess will be entertained for wrong categorization, excess payment and avoidable payments etc., to the APTRANSCO and the responsibility will be fixed on the Unit-in-Charge for such irregular payments.
