The Govt, of India vide notification 1st cited brought out certain security features by amending the rule no. 50 of CMVR 1989 (ie., form and manner of display of registration marks on the motor vehicles). The amended rule is reproduced hereunder.

Sub Rule (1) :--

On or after commencement of this rule, the registration mark referred in sub section (6) of Section 41 shall be displayed both at the front and at the rear of all motor vehicles clearly and legibly in the form of security licence plate of following specifications, namely :-

- (i) The plate shall be a solid unit made of 1.0 mm Alu. conforming to DIN 1745/DIN 1783 (or) ISO 7591. Boarder edges and corners of the place shall be rounded to avoid injuries to the extent of approximately 10 mm and the plate must have and embossed boarder. The plate shall be suitable for hot stamping and reflective sheet has to be guaranteed for a perishable nature for minimum 5 years. The fast coloring of legend and boarder to be done by hot stamping.
- (ii) The plate should beat the letters "IND" in blue colour on the extreme left centre of the plate. The letters should be one fourth of the size of letters mentioned in rule 51 and should be buried into the full or applied by hot staping and should be integral part of the plate.
- (iii) Each plate shall be protected against counterfeiting by applying Chromium based hologram applied by hot stamping. Stickers and adhesive labels are not permitted. The plate shall bear a permanent consecutive identification number of minimum 7 digits, to be laser balanced into the reflective sheeting and hot stamping file shall bear, a verification inscription.
- (iv) Apart from the registration marks on the front and rear, the third registration mark in the form of self destructive type, chromium based hologram sticker shall be affixed on the left hand top side of the wind shield of the vehicle. The registration details such as registration number, registration authority etc., shall be issued by the registering authorities/approved dealer of the licence plates manufacturer along with regular registration marks, and thereafter if such sticket is destroyed, it shall be issued by the licence plate manufacturer or his dealer.
- (v) The plate shall be fastened with non removable/non reusable snap lock fitting system on rear of the vehicle at the premises of the registering authority.

The licence plates with all the above specifications and specified registrations for a vehicle shall be issued by the registering authority or approved licence plates manufacturers or their dealer. The Central Road Research institute, New Delhi or any of the agency authorised by the Central Government shall approve the licence plates manufacturers to the above specification.

- (vi) The size of the plates for different categories of vehicles shall be as follows.

The size of letters and numerals of registration marks shall be as follows ie., as per Rule 51 of CMV Rules.

message), the above statement shall be applicable for all new buses registered on or after 30th June 2002 and for the old vehicles already registered two years from the date of commencement of the Rule.

However, the new colour schemes, black numbers on yellow back ground in case of transport (commercial) vehicles and black numbers on white back ground in case of non transport (private) vehicles, shall be implemented w.e.f. 1st Feb. 2002.

Therefore it is advised to take action for :

- 1) Implementation the new colour scheme of black numbers on yellow back ground for all the vehicles of Corporation by 1st Feb. 2002.
- 2) Introduction of new Security Registration Plates for the new vehicles at the time of registration w.e.f. 30 th June 2002.
- 3) Completion of switching over to new Security Registration plates for the old vehicles already registered within two years from the date of procurement of Rule i.e., 30th June 2002.
