Sub: MAINTENANCE -I Revision of Engine Oil change period in HINO 6E EURO-I Engines of M/s Ashok Leyland Limited - Instructions issued - Reg.

Ref: 1) Circular No. 17/2000-MED, dated-24-05-2000.

2) Ashok Leyland Service Bulletin No. 818, Sept, 2002.

Vide circular cited, instructions were issued to use Multi Grade Engine Oil of grade 15W40 on all HINO 6E Engines (Euro-I) with a drain interval of 15000 KMs as per the recommendations of M/s Ashok Leyland Limited. Now M/s Ashok Leyland Limited have informed vide Service Bulletin cited that they have revised the Engine Oil change period from 15000 KMs to 16000 KMs for their HINO 6E EURO-I Engines (CMVR 2000).

M/s Ashok Leyland Limited have also informed that there is no change in the existing specifications arid grade of Engine Oil used for Hino 6E EURO-I Engines.

In view of the above it is decided to revised the drain period of Engine Oil for HINO 6E Euro-I Engines meeting CMVR 2000 norms from 15000 KMs to 16000 KMs.

There is no change in the existing Engine Oil drain period of 15000 KMs for HIN06D engines and Hino 6E Euro-0 Engines.

All Depot Managers of Leyland area are advised to note the change of drain period of Engine Oil of 16000 KMs for Hino 6E Euro-I Engines and ensure to implement the same with immediate effect.

All the Dy.CMEs of Leyland area are advised to ensure the implementation of revised instructions in respect of Engine Oil drain period for HINO 6E Euro-I Engines at the Depots of their jurisdiction with immediate effect.

All COSs of Leyland area are advised to procure the Engine Oil for the use of HINO 6E Euro-I Engines only taking into .consideration the revised drain period and supply to the Depots as per their requirement.

All Regional Managers & Divisional Managers of Leyland area are advised to ensure the implementation of above circular instructions at the Depots in their jurisdiction and cross check the same during their inspections of Depots.

All Executive Director Zones of Leyland area are advised to review the implementation of circular instructions during the review meetings held at Zonal level and ensure the same without deviation.
