SUB:HSD KMPL:- Identification of Zonal PJ (Protected Journey) Driving Instructors for training of Low HSD KMPL Drivers - Instructions issued - Reg *****

The Corporation has taken up vigorous training of low HSD KMPL Drivers during the last year through regular training programs by Automobile Consultant Cum Trainer, Safety Instructor at Depots and 6 Best HSD KMPL Drivers(DRONACHAR-YAS) in each Depot. The success of such continuous training programs at Depots is seen in the quantum jump in the HSD KMPL from 5.07 in 2001-2002 to 5.24 in 2002-2003, thereby saving Rs.24.00 crores approximately to the Corporation during the year 2002-2003.

During one of the meetings of all EDs/RMs/HODs it was opined unanimously to care fully identify 5 or 6 suitable motivated Drivers in each Zone with flair & ability for training so that they can be utilised to train other Drivers in the Zone on the lines of training given by Automobile Consultant Cum Trainer.

Accordingly the ED(Zones) have identified and communicated the following 35 suitable Drivers (Zone-wise) for imparting training to the low HSD KMPL Drivers in their respective Depots of the Zone.

These Drivers are initially trained by Automobile Consultant Cum Trainer and the following guidelines are issued for effective utilisation of their services for training of low HSD KMPL Drivers in the Depots of respective Zone.

1) The above Drivers are named as "ZONAL PJ (PRO-TECTED JOURNEY) DRIVING INSTRUCTORS " with a view to distinguish them from rest of the Drivers and to give them separate identity & gain acceptability among the other Drivers. 2) They will continue to be in the rolls of their respective Depots & performing their normal duties on days on which they are not drafted for training.

3) The RMs will list out Depots & names of Drivers who are in low HSD KMPL and inform the same to ED(Zone) concerned for conducting training in those Depots.

4) The Office of ED(Zone) will maintain the list of such Depots / Drivers & draft the Zonal Instructors for imparting training to the identified Drivers in those Depots.

5) Based on the orders of ED(Zone), the DM of the Depot where this Zonal Instructor is working will relieve him for performing the training duties in designated Depots for stipulated number of days for which he is drafted.

6) The concerned DM of Depot will extend necessary help in the form of providing a spare Bus for training & booking the low HSD KMPL Drivers for training. The performance of low HSD KMPL Drivers before & after training will be recorded by the same Depot.

7) At the end of training duties the Zonal Instructor will return back to his parent Depot.

8) In order to motivate them to impart training to other Drivers & to retain interest in them, it is decided to pay a Honorarium of Rs.100/- per day on which he actually imparts training besides his regular salary. Such payment can be based on the certification of DM concerned. In addition to this, he will be eligible for payment of usual allowances during the training program for which he would be eligible (Except EPK linked incentive) as per rules.

9) They will be given a pair of Dark Blue Dress with black belt & DB Cap through respective Zonal Stores.

The ED(Zones) are advised to issue necessary instructions to the respective Regional Managers to identify the Depots & low HSD KMPL Drivers so that the training can be imparted by these instructors effectively.

The ED(Zones) are also advised to monitor the effective

implementation of the above Circular instructions.
