Detailed instructions were issued vide Circular cited, on the salient futures, maintenance aspects and spares to be stocked for maintenance of BS-II Vehicles operated in Depots of Hyderabad City Region.

In the above Circular, it is mentioned that the drain period of Engine oil for BS-II Vehicles is 10,000 KMs duly using the Multi Grade oil of two Companies i.e., Gulf Super fleet Special 15W 40 of Gulf Oil India and ELF performance Trophy DX 15W 40 of ELF Lubricants.

Now, M/s Ashok Leyland Limited have informed through their Service Bulletin that the Drain period is enhanced from 10,000 KMs to 16,000 KMs for BS-II Vehicles. They have also furnished the list of 8 brands of 15W 40 Engine oil along with firm names which are approved by them for use in BS-II Engines as against 2 brands of earlier instructions.

Hence, the following instructions are issued for maintenance of BS-II Vehicles of Ashok Leyland .

- Engine oil change period is 16,000 KMs for BS-II Vehicles.
- The list of recommended brands of 15W 40 Engine oil for BS-II Engines only is as follows:

Gulf Super fleet Special 15W 40 : Gulf Oil India

Servo Premium CG4 15W 40 : India Oil Corporation HP Milcy Eurol 15W 40 : Hidustan Petroleum MAK - CG4 15W 40 : Bharat Petroleum

Elf performance Trophy DX 15W40 : Elf Lubricants

IBP Turbo CG4 15W 40 : IBP

Turbo CG4 15W 40 : Chemoleums

VALVOLINE All Fleet Premium15W40: Valvoline Cummins Ltd

- The other instructions issued vide Circular cited at reference-1 remains unchanged.

Divisional Managers and Dy.CMEs of HCR Region are advised to note the above changes and ensure implementation of the same for BS-II Vehicles with immediate effect.

All the DMs of HCR are advised to follow the above Circular instructions on BS.II Engines with out fail.

The COS/HZ/UPL is advised to take necessary action to procure the approved brands of Engine oil & supply to the Depots as per requirement.

Regional Manager , Hyderabad City Region is advised to review the implementation of above instructions during review meeting held at Regional level.
