SUB:AWARD:- Award to one Depot in each Region for Best Upkeep of Vehicles from April 2005 to March 2006 - Instructions issued - Reg

1. Upkeep of Vehicles assumes high importance in the present days when the Corporation is finding diversion of traffic to other modes due to deficiencies in meeting expectation of the passengers. The operation of Buses punctually and regularly is essential to improve revenue of the Corporation. For this the Officers, Supervisors and Staff working in maintenance wing constantly endeavour to keep all Vehicles in road worthy condition with proper upkeep in maintenance aspects.
2. Considering this the Corporation Board vide Resolution No.93/2003, Dt07.06.2003 has approved to introduce Award Scheme of Best Depot in each Region for Best Upkeep of Vehicles for the year 2003-2004 and continued the same for 2004-2005 also. This scheme obviously resulted in competition amongst Depots of each Region for ensuring cleanliness and better Upkeep of Vehicles to improve image of the Corporation and the passenger has benefited on account of improved Upkeep of Buses.

In view of positive results in improving the Upkeep of Vehicles, VC&MD has approved the Award Scheme for the year 2005-2006 with the concurrence of FA.

3. The procedure to identify the Best Depot in each Region for Best Upkeep of Vehicles is as follows:
 - 3.A. The reckoning period of the Award will be April 2005 to March 2006.
 - 3.B. COMMITTEE FOR SELECTION:

A Committee consisting of concerned Executive Dire-

ctor(Zone), Regional Manager of the Region and Dy.CME of the Zone allotted with the Region will select one Best Depot of the Region in cleanliness of Vehicles. In view of large fleet and more Depots in HCR, there will be Two Best Depot Awards for Hyderabad (Covering the Depots of HYD and CRMR Divisions) and Secunderabad (Covering the Depots of Sec.Bad and Sanathnagar Divisions) areas.

The committee will physically inspect 30% of fleet or 30 buses whichever is higher at each depot during every inspection covering all types of Buses available in the Depot.

The committee will inspect the Vehicles of each Depot once in every quarter and allot marks based on the following criteria.

ii. FOR LUXURY & HI-TECH BUSES:

In addition to the above 10 parameters, the following three parameters shall also be taken into consideration.

1. Seat inclining Mechanism	20
2. Head rest covers	20
3. Working of TV, VCP & Cassette Player where ever provided	10

3.C. Marks will be awarded to individual Vehicles based on its Upkeep.

3.D. After evaluating marks to 100 / 130 / 150 as the case may be for Ord & Express / Luxury / Hi-Tech Vehicles, the weightage shall be taken for 100 Marks only for final evaluation.

For instance, the score of 120 out of 150 for Hi-Tech Vehicles shall be taken as having achieved 80% i.e., $(120/150) \times 100$.

3.E. The committee will recommend the Best Depot for this Award on the basis of total highest marks obtained during the four quarterly inspections put together for approval of VC&MD.

4. SALIENT FEATURES OF THE AWARD SCHEME:

- i) A cash award of Rs.5000/- will be presented to the best Depot for the upkeep of Vehicles in each Region for the year 2005-06. The amount shall be utilised for distribution of utility items to the garage staff involved in maintaining proper upkeep of Buses and supervisors in a function and also for the following special Awards & shield.
- ii) A cash award of Rs.150/- will be presented to the Depot Manager of the best depot under this scheme separately.
- iii) A cash award of Rs.100/- will be presented to the

Incharge of the garage of the best depot under this scheme separately.

- iv) An appreciation letter from ED(Z) will be presented to the Depot Manager.
- v) An appreciation letter from ED(Z) will be presented to the Garage in charge
- vi) A permanent shield will be presented to the Best depot.

5. PRESENTATION OF THE AWARD:

In order to give wide publicity, the presentation of award shall be done in a function to be organised at the depot. The selection of the Best Depot for the Award should be completed before 15th April 2006 and the approval of the VC&MD should be obtained immediately. The award presentation function should be held in the month of May 2006.

6. ALLOCATION:

Cash Award to the Depot Manager has to be allocated to AH 5269. Payments to other categories have to be allocated to AH 4769.
