Sub: **OIL & GAS CONSERVATION FORTNIGHT**:- Celebration of Oil & Gas Conservation Fortnight from 16.01.2015 to 31.01.2015 - Instructions issued - Reg.

1. INTRODUCTION:

The Ministry of Petroleum and Natural Gas(MoP&NG), Government of India has been directing to observe "OIL & GAS CONSERVATION FORTNIGHT (OGCF)" from 16th January to 31st January every year throughout the country with the objective of strengthening the oil conservation movement. The slogan for this year is "INDHAN BACHAO JAN DHAN BADHAO". In view of depleting stocks of petroleum products in the world, the conservation of petroleum products assumes global importance. Approximately 45% of total revenue of the Corporation is being spent towards the cost of HSD oil alone. Hence, the conservation of petroleum products in APSRTC plays an important role to reduce the cost of operation.

From last 4 decades, APSRTC has initiated number of technical, managerial and operational controls to achieve maximum fuel efficiency and to create an environment for success, which is reflected by a steady and significant improvement in the fuel efficiency in our organization. The average HSD KMPL has increased from 4.09 in 1980-81 to 5.16 during the year 2013-14. Dedicated and committed involvement of Drivers, Mechanics, Supervisors and Managers to improve the fuel efficiency is the secret behind the success of our organization in the conservation of precision fuel.

The education and motivation of all our employees about the need for oil conservation is a continuous process. During Oil Conservation Fortnight, all our efforts have to result in reinforcement of the message of conservation of oils.

2. PROGRAMMES DURING OIL CONSERVATION FORTNIGHT:

The Best KMPL Driver of each Depot of Zone will participate in this elocution competition. Each participant will be given a minimum of 5 minutes to talk on the topic. In this connection, Principals of all ZSTCs except Hakimpet are authorized to incur an amount of Rs.700/- towards for presenting gifts items to 2nd & 3rd best Drivers selected in elocution competition. Principal/ZSTC/Hakimpet is authorized to incur an amount of Rs.1400/- @ Rs.700/- per each Zones of Greater Hyderabad & Hyderabad.

2.6. ESSAY WRITING COMPETITION TO THE MECHANIC:

Awards will be presented to the Best Three essays received at corporate level in Essay Writing Competition for Mechanics on " THE ROLE OF MECHANICS IN FUEL CONSERVATION AND POLLUTION CONTROL". 2.7. AWARDS TO BEST HSD KMPL MECHANIC IN EACH REGION BY HPCL FOR THE YEAR 2013-14:

M/s HPCL have agreed to present an Award to One Best HSD KMPL Mechanic in each Region on the occasion of Oil Conservation Fortnight Celebrations. The RMs are already requested to inform the name of the Best HSD KMPL Mechanic of the Depot which has been selected for the Best HSD KMPL Award in the Region for the year 2013-14 and transmit the name to CME(O) on or before 20.01.2015 for further necessary action. M/s HPCL will present the awards in the awards presentation function to be held during Oil Conservation Fortnight. The date and venue of the function will be intimated separately.

- During the oil conservation fortnight, all the Depot Managers are advised to ensure exhibition of oil conservation slogans shown at ANNEXURE-A at the Depots and Bus Station premises at appropriate places, through flexi banners. The banner shall be of uniform size of 8X4 feet with Oil & Gas conservation Fortnight logo along with APSRTC logo, as shown at ANNEXURE-B
- In order to carry the message of oil conservation, simple and effective programmes are to be organized with the involvement of local officials at all the Depots.
- Depot Managers shall organize gate meetings during changeover time to educate the Drivers on the importance of Fuel Conservation.
- All the Depot Managers excluding the Depots where the Regional function is organized (mostly Headquarter Depots) are permitted to incur an expenditure of Rs.3,000/- for celebration of Oil and Gas Conservation fortnight at Depots.

- They shall also identify the low HSD KMPL Depots and address the Drivers / Mechanics of such Depots through a meeting organized during oil conservation fortnight.
- They shall arrange wide publicity on Oil Conservation Fortnight through print & electronic media.

8. ROLE OF Dy.CHIEF MECHANICAL ENGINEERS OF REGIONS DURING OIL CONSERVATION FORTNIGHT:

- Dy.Chief Mechanical Engineers of Regions shall actively participate in the functions organised at Depots / Workshops by the oil companies / OEMs to give their message on oil conservation during the oil conservation fortnight. They shall organize competitions in coordination with Oil Companies / Vehicle Manufacturers as explained in pre paras.
- They shall also identify the low HSD KMPL Depots and address the Drivers / Mechanics of such Depots through a meeting organized during oil conservation fortnight.

9. ROLE OF EXECUTIVE DIRECTORS (Zones) DURING OIL CONSERVATION FORTNIGHT:

- Executive Director (Zones) are advised to attend the functions at Depots/Regions / Workshops organized by the Oil Companies/Vehicle Manufacturers/M/S Bosch/M/S BGL to give their message during oil conservation fortnight.

The Regional Managers and Depot Managers are advised to submit a detailed report to Executive Director (E) within one week after the completion of Oil Conservation Fortnight to enable this office to send a consolidated report to the Government.


