## CIRCULAR NO. 04/2019-MED. Dt.28-01-2019

Sub: UPKEEP: Eradication of Bed bugs in High end buses - instructions issued - Reg.

Ref: Circular No. 07/2015-MED, dt.28.03.2015.

Of late the Bed bugs have become a serious menace in the High end buses at all depots especially those operating to Bangalore city. Recently, one of the passengers has complained directly to VC & MD along with the photos of the skin affected by the Bed bugs while travelling in a Super Luxury Bus.

Instructions were given through Circular No. 07/2015 - MED, dt. 28.03.2015, to carry out fumigation in the high end buses once in three months using Aluminum Phosphide tablets duly sealing the bus in air tight condition and repeat the same after 10 days on the same vehicle to completely weed out the bed bugs. Even after carrying out fumigation by using Aluminum phospide, the bed bugs problem is repeating leading to passenger complaints.

In this connection, DyCME/MTM informed that they have tried alternate fumigation methods offered by various firms viz., M/s. Central Ware Housing Corporation (Gol Undertaking), M/s DOWs Integrated Pest Control & Fumigation Services Pvt Limited etc. During the trial it is reported that fumigation method using Methyl Bromide (Liquefied gas) offered by M/s CWC is found to be very effective. Further, M/s CWC is a Govt. of India Undertaking with qualified people to carry out the fumigation process.

Hence, the Competent authority has given approval for implementation of the following:

 To carryout fumigation treatment through M/s Central Warehousing Corporation by using Methyl Bromide @ Rs 1500 /- + 18% GST per bus (Rs 1770/- including GST) for all buses, Ultra deluxe and above category operating on Bengaluru route with a periodicity of 10 days initially (i.e 10 days gap between the 1<sup>st</sup> treatment and 2<sup>nd</sup> treatment) and then onwards at a periodicity of 3 months.

- To carryout fumigation even before the scheduled period of 3 months whenever passenger complaints are received on buses operating in Bengaluru route
- To carryout fumigation for the buses operating on routes other than Bengaluru and on which passenger complaints received on bed bugs problem.

All the Depot Managers are advised to undertake fumigation treatment for all High end buses once in a quarter as detailed above and ensure that bed bugs menace is totally eradicated. Records shall be maintained regarding the dates of carrying out fumigation and next due dates to be done. The list of CWC warehouses along with the ware house manager, mobile number and email address is enclosed at annexure-1.

All the Depot Managers are advised to contact the nearest warehousing manager to take up the fumigation activity in true spirit and inform the number of buses taken up on fortnightly basis to CME(M).

Dy.CMEs are advised to review the progress periodically and also during their depot visits / inspections.

RMs & EDs are requested to ensure to review the progress of fumigation during their review meetings & visits to depots.

This has the approval of VC&MD with the concurrence of FA&CAO.

"There should not be any bed bugs in APSRTC buses".
