The VC & MD with the concurrence of FA has accorded sanction to continue the Monthly Cash Award scheme to the 1st & 2nd best HSD Saved Drivers for the year 2018-19 also (i.e. from April'18 to March'19) and to present cash awards @ Rs.500/-, Rs.300/- to the 1st & 2nd best Drivers respectively of the Depot every month. There is no change in the terms & conditions stated in the Circular No.09/2009-MED, Dt.01.06.2009 and notification cited at reference no.s (2) to (9).

The VC & MD has also accorded sanction with the concurrence of FA & CAO to present similar Cash Awards of Rs.500/- & Rs.300/- to the 1st & 2nd best Drivers respectively every month at three Depots of GVPT-2, VDPM & IBM of Krishna Region for highest CNG savings only. At these 3 Depots cash awards shall not be presented for diesel savings as diesel buses are very few in these depots.

All the RMs, Dy CMEs & DMs are advised to give wide publicity to this Award Scheme and also present the cash Awards on or before 7th of every month without fail to motivate the best performance Drivers so as to achieve target KMPL by the depots.
