Sub: **UPKEEP** -Upkeep of Driver's cabin to perform comfortable and happy duty resulting in reduction of maintenance cost and improvement of revenue - Certain instructions issued for strict implementation- Reg.

Aesthetic appearance and good upkeep of buses is essential to attract passengers and to improve revenue of the Corporation. Driver plays a vital role in achieving the above objective. The Drive requires a better ambience at his work place to offer excellent journey to the commuters. Thus the upkeep of Drivers' cabin is more important to perform the duty in an excellent way by a Driver without involving any inconvenience and fatigue.

It is understood that the drivers are expressing displeasure over the present condition of the Drivers' cabin and it has to be addressed immediately to satisfy the Drivers' community.

In this connection, all the Regional Managers are advised to arrange to take census on the present condition of following items immediately and to chalk out a plan of action for correcting the deficiencies noticed during the inspection.
