1. The Oil companies have revised the HSD Oil rate upwards on 05-11-2004.
2. As recommended by the Committee, VC & MD has approved the revised hire rates payable per kilometer to all following 4 category of hire buses under operation.
3. The revised hire rates for implementation are as detailed below.

The revised hire rates payable for all types of hire buses of 2003 model introduced in pursuance of Notification of hiring of private buses issued on 01-03-2003 and for all types of hire buses of **2003 or later models** supplied from February, 2003 onwards as replacements, are as detailed below.

Further, it is also instructed that, before implementation of above hire rates, It shall invariably be ensured that the instructions issued vide circular in reference 3rd cited are complied with i.e., whenever the hire rates are revised downwards, the amount that should be recovered are promptly recovered in the ensuing bills and the amounts payable due to upward revision in hire rates being promptly paid.
