Therefore, all the Regional Managers are hereby advised to implement the above provisions of M.V.Act on safety gadgets i.e wearing of Helmet by rider of all Departmental two wheelers, fastening of Seat Belt by all the drivers of Departmental LMVs (Cars and Jeeps etc.), front occupants of all LMVs and fastening of Seat Belt by Drivers of all types of City & District buses while driving the vehicle. Further, all the employees of Corporation are also advised to wear Helmet while riding two wheeler.

Non-compliance of the provisions attract a penalty of Rs.100/- to the driver for violation of Section 138(iii)/177/129 of M.V.Act 1988.
