Sub : **LICENSING** - Calling tenders for allotment of Stall / Shop / Open area of 10'x10' at Bus Stations for Water KIOSK to sell purified drinking water - Reg.

\*\*\*\*

Representations are being received from Passengers' Associations, Peoples' representatives and general public, to provide purified drinking water in Bus Stations at reasonable rate, since all passengers cannot afford to purchase mineral water.

The matter has been examined and it is decided to provide purified drinking water as per the standards of Bureau of Indian Standards (BIS) to the travelling public at Bus Stations at reasonable rates, through "WATER KIOSK" by allotting vacant stall / shop / open area by calling tenders.

The Regional Managers are therefore advised to call tenders for allotment of vacant stall / shop or open area of 10'x10' (depending upon availability) at all potential Bus Stations, for "WATER KIOSK" to sell purified drinking water as per the provisions of Bureau of Indian Standards (BIS). The tenderers shall enclose a certificate issued by BIS / or manufacturers of purified drinking water holding BIS certificate, to the Tender form, that the tenderer will be supplied with purified drinking water as certified by BIS to sell in the KIOSK. The allottee of water KIOSK shall sell purified drinking water procured from the manufacturer / authorised by BIS.

The allottee need not establish water purification plant in the stall, but has to procure water from the firms authorised by BIS, to sell in the stall.

The allottees of water KIOSKs have to sell the purified drinking water at the following maximum rates.

The above rates shall be specified in the terms & conditions of the Tender, to be supplied to the tenderers alongwith Tender form.

The other terms & conditions of the Tender shall be as per the Cir.No.17/2003-OPD(C), dt.20.2.2003.

In Major and A Class Bus Stations, where there is need to have more than one WATER KIOSK, action shall be taken to allot more than One WATER KIOSK under "Non-exclusive clause".

The vacant stall / shop / open area proposed for WATER KIOSK shall be as far as possible at prime location and it shall not be nearer to the toilets/lavatories / urinals.

Open area shall be identified for WATER KIOSK only when there is no vacant stall / shop in the Bus Station.

The Regional Managers are advised to finalise the allotment of WATER KIOSK by the end of February'2005, to enable the successful tenderers of WATER KIOSK to commence business in March'2005.
