Sub: ATB Agents - Commission to the ATB Agents for booking of tickets in GARUDA Buses - Revision of Fare Slabs for commission to Garuda buses consequent to fare revision wef 07-01-2010- Issue of Instructions - Reg.

Fare based commission rates to ATB Agents were communicated vide circular at reference, to encourage the ATB Agents for booking tickets of Garuda services.

Consequent to the fare revision with effect from 07.01.2010, the fares of Garuda services increased by 25 ps per Km. whereby outflow of commission boosts up to ATB agents since commission is based on fare slabs. Therefore the fare slabs are revised as follows to regulate the out-flow of commission to ATB Agents wef 7-1-2010.
