Attention is invited to this Office Circular No.28/2000, wherein instructions were issued in regard to revision of bus fares in respect of all types of stage carriage services including City / Town services for implementation w.e.f. 06.10.2000.

Several complaints are being received from travelling public, public representatives as well as from Press stating that the conductors of City / Town services are not returning back small change due to them. The fare for the alternative stages from 3rd stage onwards of City / Town ordinary services are multiples of 25 ps. Coins of 25 ps. are not available in required quantities in the market and the conductors / Corporation are also facing much difficulty in procuring them. This issue was published in local news papers several times. Many instances of friction between the commuters and the conductors have also come to our notice.

The matter has been examined and it is decided to roll back the fares in respect of City / Town ordinary services. The details of the fare structure (existing and revised) of City / Town ordinary and Green Express services are enclosed vide Annexure-A.

OVER STAMPING OF TICKETS :


The existing ticket denominations will be sufficient to implement the proposed fares. There will be no need to over stamp the existing tickets and the Works Manager (P&S) is being requested not to print the ticket denominations of Rs.3.75, Rs.4.75, Rs.5.75 etc., which were required for City / Town services after the fare revision w.e.f. 06.10.2000. Separate instructions are being issued regarding destroying of the existing over stamped tickets in respect of City / Town services.
