Sub: BUS PASSES – Issue of concessional bus passes to the State Government employees (hitherto NGOs) working in **AP Secretariat, Velagapudi** – Revision of Tariff – Communication of orders – Reg:

Vide letter No.1785/SW/A2/2016-dated 07-12-2016, it was informed by the Secretary to the Government – GAD (SW) that all the Government Departments have shifted from Common Capital of twin cities of Hyderabad and Secunderabad to new Capital Region of Amaravati from 27-06-2016 onwards and also AP Secretariat is functioning from Interim Secretariat Complex at Velagapudi w.e.f. 03-10-2016.

Vide GO cited under 1st reference Government permitted to

- Extend the Concessional monthly bus pass facility to the NGOs of A.P. Secretariat at Velagapudi at the rate of Rs.1350/- with 2/3rd Government Share of Rs. 900/- and 1/3rd Employees share of Rs.450/- up to the facility of Ultra Deluxe Buses operating in CRDA Limits.

- Extend the above Concessional monthly bus pass facility to the Gazetted officers of A.P. Secretariat at Velagapudi and

The above Concessional Bus pass facility shall also extend to the Class – IV Employees, outsourcing and Contract employees who are working at A.P. Secretariat at Velagapudi

✓ Accordingly orders are hereby issued to issue

- Bus pass to the Employees of A.P. Secretariat at Velagapudi at the rate of Rs.1350/- with 2/3rd Government Share of Rs. 900/- and 1/3rd Employees share of Rs.450/- up to the facility of Ultra Deluxe Buses operating in CRDA Limits.
 - Special Privilege Bus Passes to the Employees/ outsourcing and Contract employees as informed by GAD (SW) on collection of stipulated ID cum renewal charges duly foregoing the employees share as per practice in vogue.

The above instructions are applicable to the employees, outsourcing and Contract employees who are working at A.P. Secretariat at Velagapudi only, and cannot be interpreted to other employees working in the departments shifted from Hyderabad in the vicinity of CRDA.

Government Employees who are hitherto availing Concessional Bus Pass facility as per GO RT 1052 dated 16-05-2016 in Vijayawada and Visakhapatnam Cities do not come under the purview of this circular.

The instructions, Tariffs, validity in class of services (City Ordinary/Metro Express) communicated vide Circular No. 09/2015 shall hold good until further instructions.
