The Oil companies have revised the HSD Oil rate upwards on 15.02.2008.VC & MD accorded approval for implementation of the revised hire rates as recommended by the Committee constituted to review hire rates.The revised hire rates payable to hire buses w.e.f 15-02-2008 are as detailed below.

Category -1

The revised hire rates payable w.e.f 15-02-2008 for all types of hire buses of 2003 model introduced in pursuance of Notification of hiring of private buses issued on 01.03.2003 and for all types of hire buses of 2003 or later models supplied from February, 2003 onwards as replacements, are as detailed below.



The revised hire rates shall be endorsed in the agreements entered into by way of issue of an amendment duly acknowledged by the hire bus owners. The payment of hire charges bills shall be pre-audited. Further it is also advised that before implementation of above hire rates, it shall invariably be ensured that the instructions issued vide circular 3rd cited in reference are complied with i.e., whenever the hire rates are revised downwards, the amount that should be recovered are promptly recovered in the ensuing bills and the amounts payable due to upward revision in hire rates being promptly paid.
