Sub: LICENSING - Sale of Mineral Water in Bus Stations by the existing licensees on payment of additional licence fee - Instructions - Regarding.

Ref: Circular No.19/2001-OPD(C), dated. 12-04-2001.


Instructions were issued vide circular cited to permit the existing licensees of Canteens / Stalls to sell mineral water on payment of additional licence fee as decided / fixed by the Regional Tender Committee, depending upon the importance and business potentiality of the bus station. Also, it was made clear, not to permit any other licensee to sell mineral water, if licence is given for sale of mineral water exclusively in any bus station.

Corporate Office has called tenders and finalised allotment of 6'x 6' spaced at certain has stations on payment of monthly licence fee for installation of 'KIOSK' to sell safe drinking water exclusively. The licensees of KIOSKS installed to sell safe drinking water, have represented, that allowing all licensees in bus stations to sell Mineral water is hampering their business prospects.

In the light of the above representations, the matter has been examined and the following instructions are issued:

1. In Bus Stations, where licence is given for sale of mineral water exclusively, or for installation of KIOSK to sell safe drinking water, no other licensee shall be permitted to sell Mineral water.

If permission is already given for sale of mineral water on payment of additional licence fee prior to installation of exclusive mineral water stall/KIOSK for sale of safe drinking water, it shall be continued till the completion of the licence period of the stall.



^{3.} The Tender Committee, while fixing the additional licence fee towards sale of Mineral water, shall take into consideration, the business potential of the stall, the monthly licence fee being paid etc. However, the additional licence fee to be fixed in future, towards sale of Mineral water shall not be less than.

- (a) Rs.3,000/- per month in case of stalls located in Major Bus Statio..s (MGBS, JBS, KRMR, HNK (Dist. Bus Station), KRNL, CBS(TPT), SBS(TPT), NLR, GNTR, PNBS(VJA) & Dwaraka Bus Station, (VSP).
- (b) Rs.2,000/- per month in case of stalls located in District Bus Stations (Bus Stations located in Dist. Headquarters other than major Bus Stations.(c) Rs.1,000/- per month in case of Bus Stations located at other places.
- 4. Permission shall be given for sale of Mineral water on payment of additional licence fee, to only those licensees doing related business. For example Canteen, Fast Food Centre, Soda Stall, Cool Drinks Stall, Soda & Cool Drinks Stall, Bakery Stall, Fruit Juice Stall.
- 5. The permission to sell Mineral water is Co-terminus with the licence period of the stall as per the deed of licence. This condition shall be incorporated in the letter itself.
- 6. Permission accorded to the existing licensees of Stalls/ for sale of Mineral water on payment of additional licence fee, does not preclude the Corporation from granting licence for exclusive Mineral water stall or KIOSK to sell safe drinking water in the same bus station. In other words, Corporation reserves right to grant licence for exclusive Mineral water stall or KIOSK at the same bus station even if permission is given to the existing licensees of Stalls/Shops for sale of Mineral water on payment of additional licence fee.
- 7. The licensees of KIOSKS installed for selling safe drinking water in bus stations, shall be allowed to sell safe drinking water in 100 ml. and 200 ml. sachets at a price of Re.1/- and Rs.2/- respectively. The water sachets shall be sold in the KIOSK only. Under no circumstances the water sachets shall be allowed to sell through hawkers.
- 8. Immediate action shall be taken to stop sale of mineral water unauthorisedly by the licensees without paying additional license to the Corporation.
