Sub: BUS PASSES - Issue of concessional bus passes to the students attending "summer crash courses" being conducted at Govt Junior Colleges - Requested - Reg.

2) Discussion held on 21.03.2007 with Prl Secretary to Govt, TR&B Dept

The Commissioner of Intermediate Education Govt of AP vide letter 1st cited informed that the Government have permitted to conduct the EAMCET coaching classes at 23 Junior Colleges, one in each district and short term Vocational Certificate courses, crash courses in spoken English in some identified Government Junior colleges. The Commissioner of Intermediate Education requested to issue concessional bus passes to the students attending these crash courses being conducted at Government Junior Colleges. Approximately 15,300 students are expected to enroll in various Govt. Junior Colleges of State for the above summer crash courses.

The Prl Secretary to Govt TR& B Dept during the meeting held on 21.03.07 directed the Corporation to extend concessional bus pass facility to those students who attend the summer crash courses being conducted in Government Junior colleges as identified by the Education Department.

The matter has been examined in detail and it is decided to extend the concessional bus pass facility only to those students who attend the summer crash courses in Government identified junior colleges during the months of April 2007 to June 2007. The following guidelines are issued for strict compliance.

- The student who is willing to obtain concessional monthly / quarterly Student
 Bus Pass to attend summer crash courses in Government identified junior
 colleges should produce Bonafide certificate duly signed by the Principal /
 Head of the Government Junior college as identified by Education Dept where
 the summer crash courses will be conducted.
- 2. The Unit officer should insist a copy of the letter issued by Education Department from Government Junior college permitting to conduct summer crash courses in that College itself.
- 3. The units should maintain a separate register and furnish the issues of these Student bus passes separately in the monthly periodical submitted to Regional office and in turn to Corporate office under the item "Summer crash course Student Bus Pass A) Monthly B) Quarterly."

Therefore all the regional managers and Depot managers are requested to follow the above instructions scrupulously and report compliance.
