- Wide Circular cited at reference 1, instructions
 were issued to all Executive Directors of Zones
 and Regional Managers for arranging payment of
 monthly Cash Award of Rs.200/- per Conductor or
 Driver, who do not avail any leave or compensatory
 offs, quring the months of May and June 2000.
 - 2. This Scheme has been introduced on an experimental basis with a view to motivate the crew and ensure their availability for duties on all days during peak season with an ultimate objective to minimise cancellations, reduce payment of over time, induce crew to postpone leaves voluntarily and endeavour to provide punctual and reliable service.
 - 3. On assessing the impact and viability of the Scheme, it is observed that the Scheme has made a positive impact in improving the attendance of crew and reducing the cancellation of kilometres for want of crew during the months of May and June, 2009.
 - It is therefore decided to implement the Cash Award Scheme to crew during the peak season of the current year i.e., during the months of March, April, May and June 2001.
 - 4. The guidelines issued for implementing the Cash Award Scheme vide Circular No.15/2000-OPD-T, Dated 29-05-2000 hold good for implementing the Scheme in the current year also i.e., during March, April, May and June 2001.



- a. The Scheme is valid for only four months i.e., March, April, May and June 2001. The Management has the right to extend, withdraw or modify the Scheme at any time.
- b. The Executive Directors of Zones, Regional Managers and Dy.Chief Traffic Managers shall inspect the Registers maintained in this connection during their visits to Depots.
- c. The amount shall be drawn under Account Head Number 4569 for Drivers and 4669 for Conductors and payment be arranged along with the monthly incentive through a separate bill in the succeeding months after pre-audit. The payment of Cash Award is in addition to the regular incentive amount to the eligible crew.
- d. Adequate and necessary publicity should be given at all the Depots through Notice Boards/ Gate Meetings for motivating the crew and thereon the resultant benefits to the crew on improving their attendance. The list of crew who have achieved the Cash Awards should be displayed conspicuously on the notice boards to attract the remaining crew into the fold of withe scheme.
- e. The Traffic Supervisors shall play an active and catalytic role in motivating the crew and to achieve the objectives of the scheme.
- f. The above instructions are valid from 01-03-2001 to 30-06-2001 only.



All the Regional Managers, Depot Managers and Field Officers shall continuously monitor the implementation of the Scheme and ensure:

- a. progressive reduction in the double duties of crew,
- b. progressive increase in the availability of crew and
- c. minimum cancellation of kilometres for want of crew.



The Regional Managers shall review the impact of the Scheme at all the Depots under their jurisdiction on a monthly basis preferably during the monthly review meetings with the Depot Managers and critically examine the improvement in attendance of crew, reduction of double duties, overtime allowance to crew, reduction in cancellation for want of crew, expenditure incurred due to payment of cash award to crew etc., in the prescribed proforma enclosed.

The Regional Managers shall send the information pertaining to their Regions for each month from March to June, 2001 in the prescribed proforma to CTM(R&D) by 5th of succeeding month for a detailed analysis and evaluation of the Scheme.
