Sub: LICENSING:- Allotment of stalls to SC/ST/PEBC candidates in the Bus stations - Description of Poorer Economically Backward Classes (PEBC) - Reg.

Ref:- Circular No.13/2003, Dt.13.02.03.

Instructions were issued vide circular cited with regard to allotment of stalls/spaces in the Bus stations to SC/ST/PEBC candidates. But there was no specific description of the term "Poorer Economically Backward Class(PEBC)", i.e. which candidates fall under this category and what is the limit of income for a PEBC candidate.

Many RMs are requesting for a directive whether BC candidates can be allowed to participate in the tenders for the stalls earmarked for SC/ST/PEBC irrespective of their economic status. Also they requested to clarify whether OC candidates can be allowed if they produce income certificate stating that they are poor and economically back ward.

In regard to above, the following clarifications are issued.

- 1. The Ministry of Personnel, Public Grievances & Pensions, Govt. of India issued the income criteria, Dt.14.10.08 to exclude socially advanced persons/sections (Creamy Layer) from the purview of reservation for Other Backward Classes (OBCs).
- 2. According to the above, the son(s) and daughter(s) of the persons having gross annual income of Rs.4.5 lakh or above or possessing wealth above the exemption limit as prescribed in the Wealth Tax for period of three consecutive years will fall within the creamy layer and would not be entitled to get the benefit of reservation available to the OBCs.

- 3. Thus the BC candidates whose gross annual income is below Rs.4.5 lakhs per annum shall only come under 'PEBC' category and are eligible for participating in the tenders called for the stalls earmarked for SC/ST/PEBC.
- 4. The reservation is meant for Back Ward Classes only. OC candidates shall not be allowed to participate in the tenders for filling up of vacant stalls earmarked for SC/ST/PEBC candidates even though they produce income certificate for less than Rs.4.5 lakhs per annum.

The Regional Managers shall accept the Income Certificates issued only from concerned MRO/Revenue Department. The annual income limit may vary from time to time as per instructions issued by Govt.of India. Hence the Regional Managers shall ensure the limit of Income from Revenue Department from time to time whenever the tenders are called for the vacant stalls in the Bus stations earmarked for SC/ST/PEBC candidates and take action accordingly.
