Ref: Circular No. 39/2004 dt. 9-8-2004

Fare based commission rates to ATB Agents for booking tickets in Volvo and King long buses were communicated vide circular at reference to encourage the ATB Agents in booking tickets for Garuda services.

Consequent to the fare revision with effect from 8-2-2006, the fares of Garuda services were increased by 10 ps per Km. With the hike in fares, outflow of commission boosts up as the commission to ATB agents in case of Garuda services is based on fare slabs. Therefore it would be appropriate to revise the fare slabs to regulate the out-flow of commission.

VC & MD has approved for revision of fare slabs as below:

The above revised fare slabs for payment of commission to ATB Agents in case of Garuda services will come into force with effect from 16-5-2006.

Therefore it would be appropriate to revise the fare slabs to regulate the out-flow of commission.
