Sub: **FARES - RATIONALISATION OF FARES** of city buses in respect of all City Ordinary, Metro Express and Metro Deluxe services operating in the Corporation - Reg.

Corporation issued circular instructions to the units vide reference 1st cited for revision of fares of all types of services w.e.f.06/07.01.2010. However owing to representations from various cross sections of people, print and electronic media , the Government vide G.O. 3rd cited reduced the minimum fares of City Ordinary, Pallevelugu and Express type services to which effect instructions were also issued to the units vide letter 2nd cited.

Despite of reduction in Minimum fare from Rs.5/- to Rs.4/- for first two stages in City Ordinary services, many representations have been received for reduction in other fare stages also in all types of city services, since charging more than the travel distance by keeping one slab fare from 6 to 12 Kms, 14 to 20 Kms, 22 to 28 Kms is not rational. Further there is also scope for reissue of tickets by conductors and recirculation with in passenger themselves.

Taking all the above factors into view, a study to asses the impact of fare hike in city services of all buses was conducted by committees constituted at zonal level for rationalization of city passenger fares in respect of City ordinary, Metro Express and Metro Deluxe services

After thorough deliberations and market surveys undertaken by Zonal Executive Directors with the concurrence of Financial advisor, it is decided to rationalize the Bus fares in respect of City Ordinary, Metro Express and Metro Deluxe services in Greater Hyderabad, Vishakapatnam, Vijayawada and Warangal as shown below in order to facilitate the city commuters with reasonable fares and to avoid deflection to other modes of transport.

As the ticket denominations Rs.5.00, Rs.6.00, Rs.8.00, Rs.11.00, Rs.15.00 Rs.18.00 and Rs.23.00 are not readily available with the depots, it is decided to permit the following combination till such time the stock is procured from Central Stores, Miyapur.
