Attention is invited to the Circular 1<sup>st</sup> cited, through which Corporation has revised the fare in respect of all types of stage carriage services including City Sub-urban, Metro Express Sub-urban services. In order to meet the increased cost of operation Corporation has also revised the special hire tariff of various types of buses, in line with the revision of fares w.e.f. 08.02.2006 except in respect of City Ordinary, Metro Express and Metro liner services vide Circular 2<sup>nd</sup> cited.

Owing to increase in Metro Express Suburban fares w.e.f. 08.02.2006, Corporation has decided to revise the special hire tariff of Metro Express and Veera services.

The following is the revised special hire tariff of Metro Express and Veera buses.

SL. NO.	TYPE OF BUS	EXISTING TARIFF PER KM.	REVISED TARIFF PER KM.
1.	Metro Express	Rs.23.00	Rs.25.00
2.	Veera / Metro liner	Rs.24.00	Rs.26.00

The existing procedure of allowing a concession of Rs.2/- per KM. in case of buses being engaged by the Public Sector Undertakings / Industrial Establishments, Educational Institutions on long term contract basis, shall be continued only for Ordinary type services and no concession in special hire tariff shall be allowed in respect of Metro Express and Veera / Metro liner services provided on special hire basis to Public Sector Undertakings and Industrial Establishments.

All the terms and conditions with regard to providing buses on special hire basis communicated vide Circular 09/2006-OPD(P) Dt .27.02.2006 shall remain unchanged. The revised special hire tariff in respect of Metro Express and Veera / Metro liner shall come in to force w.e.f. 01.06.2006.

There is no change in the special hire tariff Rs.23.00 in respect of City / Sub-urban Ordinary services.
